CREDIT AGREEMENT



Between _____

(Hereafter referred to as "the Customer") and BE Pressure (NW USA), LLP and BE Pressure (SE USA), LLP and BE Pressure (MW USA), LLP and Barens Inc. (Hereafter referred to as BE USA).

The Customer hereby certifies that the information provided in the "Credit Application" to BE USA about the Customer is true, correct and agrees with BE USA, and that if this application is accepted, to aide and be bound by the terms and conditions set forth below in this Credit Agreement which the Customer acknowledges having received and read.

The Customer hereby authorizes BE USA to obtain such credit reports or other information as may be required in connection with the establishment and maintenance of a credit account, or, for any other direct business requirement in connection herewith. The Customer further authorizes, upon request to such other persons as BE USA may consider appropriate, to provide the same above information.

The Customer agrees to be liable for all merchandise billings and late payment service charges to their account with BE USA. The Customer shall pay on or before the due date shown on each invoice charged to their account with BE USA. Standard terms being 30 days from date of invoice.

Account balances outstanding after the due date will receive a 2% interest charge monthly on the outstanding balance.

Upon default on breach of this agreement by the Customer (Which shall include without limitation the failure to

observe or perform any obligation herein, the failure to pay any installment when due, or exceeding of the Customer's credit limit,) BE USA shall have the right, as its option and without limiting of affecting any other remedies it may have hereunder, at law or in equity, to: terminate this credit agreement, declare the outstanding balance including any service charges to be immediately due and payable in full, and take other action it may deem necessary to collect the outstanding balance.

We, The Customer, acknowledge that this credit account is to be operated under the personal credit strength of the undersigned and that I/We personally acknowledge responsibility for the payment of this account as outlined under the terms above.

All returns must be authorized by the credit department, returned with the original invoice, and are subject to a restocking charge of up to 20%.

The credit agreement shall be subject to all applicable state federal legislation.

This credit account and all amounts due hereunder can be assigned by BE USA without further notice to the Customer.
